#### 1 Name of Plan

## Schedule 1 Amendment of Liverpool Local Environmental Plan 2008

#### [1] Land Use Table

Insert "Veterinary hospitals;" in alphabetical order in item 3 of the matter relating to Zone RU4 Primary Production Small Lots.

#### [2] Land Use Table, Zone B3 Commercial Core

Omit "Sex services premises;" from item 3.

#### [3] Land Use Table, Zone IN1 General Industrial

Insert "Vehicle body repair workshops; Vehicle repair stations;" in alphabetical order in item 3.

#### [4] Land Use Table, Zone IN3 Heavy Industrial

Omit "Recreation facilities (indoor);" from item 3.

#### [5] Clauses 7.33 and 7.34

Insert after clause 7.32:

### 7.33 Dwelling houses in Zone R3 and Zone R4—height and floor space ratio controls

- (1) This clause applies to land in the following zones:
  - (a) Zone R3 Medium Density Residential,
  - (b) Zone R4 High Density Residential.
- (2) Despite clauses 4.3 (2) and 4.4 (2), development consent must not be granted to development for the purpose of a dwelling house on land to which this clause applies unless:
  - (a) the dwelling house will not exceed a height of 8.5 metres, and
  - (b) the floor space ratio of the dwelling house will not exceed 0.6:1.

## 7.34 Dwelling houses at Church and Campbelltown Roads, Denham Court and Greendale Road, Wallacia—amalgamation of lots

- (1) This clause applies to the following land:
  - (a) land at Denham Court, being:
    - (i) Lots 10, 20 and 21, Section B, DP 1443, being land fronting Church and Campbelltown Roads,
    - (ii) Lots 11 and 19, Section B, DP 1443, being land fronting Church and Campbelltown Roads,
    - (iii) Lots 17 and 18, Section B, DP 1443, Campbelltown Road,
    - (iv) Lots 27 and 28, Section B, DP 1443, Campbelltown Road,
    - (v) Lots 29–31, Section B, DP 1443, Campbelltown Road,
    - (vi) Lots 32–34, Section B, DP 1443, Campbelltown Road,
    - (vii) Lots 35–37, Section B, DP 1443, Campbelltown Road,
  - (b) land at Greendale Road, Wallacia, being:
    - (i) Lots 101 and 102, DP 1174458,
    - (ii) Lots 13 and 14, DP 18891,
    - (iii) Lots 15 and 16, DP 18891,

#### (iv) Lots 50 and 51, DP 18891.

(2) Despite any other provision of this Plan, development consent must not be granted to development for the purpose of a dwelling house on land to which this clause applies, being land comprising the lots referred to in subclause (1) (a) (i), (ii), (iii), (iv), (v), (vi) or (vii) or (b) (i), (ii), (iii) or (iv) unless the land comprising the lots referred to in that subparagraph has been amalgamated into a single lot.
