1 Name of Plan

This Plan is Eurobodalla Local Environmental Plan 2012 (Amendment No 6).

2 Commencement

This Plan commences on the day on which it is published on the NSW legislation website.

3 Land to which Plan applies

This Plan applies to the following land:

- (a) certain land to which Eurobodalla Local Environmental Plan 2012 applies,
- (b) certain land to which *Eurobodalla Rural Local Environmental Plan 1987* applies.
