### 1 Name of Plan

This Plan is Camden Local Environmental Plan 2010 (Amendment No 19).

  - (g) Lot 3513, DP 830128, 55 Topham Road, Smeaton Grange.
- (2) To the extent that this Plan corrects the address and property description of a heritage item, this Plan applies to 40 Exeter Street and 75 and 75A Macquarie Grove Road, Camden.
