1 Name of Plan

This Plan is *Bland Local Environmental Plan 2011 (Amendment No 1)*.

2 Commencement

This Plan commences on the day on which it is published on the NSW legislation website.

This Plan applies to the following land:

- (a) 29 and 82 Ungarie Road, West Wyalong, being Lots 381 and 604, DP 753135,
- (b) Lot 1, DP 1132536 and Lots 67–75, DP 750615, Newell Highway, Wyalong,
- (c) 34 Showground Road, West Wyalong, being Lots 1379 and 1380, DP 705311,
- (d) Lot 3 and Part Lot 4, DP 1207405 and Lot 266 and Part Lot 30, DP 750615, Compton Road, West Wyalong,
- (e) Lot 4, DP 752319 and Lot 1, DP 724512, Rankins Springs Road, Naradhan.

4 Maps

Schedule 1 Amendment of Bland Local Environmental Plan 2011

- (2) Development for the purposes of shops is permitted with development consent.
