State Environmental Planning Policy Amendment (Estimated Development Cost) 2023

1 Name of policy

This policy is State Environmental Planning Policy Amendment (Estimated Development Cost) 2023.

2 Commencement

This policy commences on 4 March 2024 and is required to be published on the NSW legislation website.

3 Repeal of policy

This policy is repealed at the beginning of the day following the day on which this policy commences.
