#### **JUSTICES ACT 1902—REGULATION**

(Relating to short descriptions of offences under the National Parks and Wildlife (Land Management) Regulation 1987)

The National Parks and Wildlife (Short Description of Offences) Regulation 1989 is amended:

- (a) by omitting clause 2 (2) and by inserting instead the following subclause:
  - (2) If a choice of words is indicated in Column 2 of the Schedule, the words remaining after the omission of the words inrelevant to the offence constitute the prescribed expression.
- (b) by omitting Schedule 1 and by inserting instead the following Schedule:

Clause 61 (1) (b)—person refusing or neglecting to comply with any reasonable request or reasonable direction made or given by the Director or the trustees or an officer or employee of the Service or an authorised person, being a request or direction relating to an act or omission by the person within a park

#### **EXPLANATORY NOTE**

The object of this Regulation is to amend the National Parks and Wildlife (Short Description of Offences) Regulation 1989 so as to amend the prescribed short descriptions that, by virtue of the Justices Act 1902, are sufficient to state or describe in any information, complaint, summons warrant, notice, order or other document certain summary offences under the National Parks and Wildlife (Land Management) Regulation 1987.
