Explanatory note

The object of this Regulation is to amend the *Private Hospitals Regulation 1996* and the *Day Procedure Centres Regulation 1996* so as to increase the following fees:

- (a) application fees for licences for private hospitals and day procedure centres,
- (b) application fees for the transfer of licences for private hospitals and day procedure centres,
- (c) annual licence fees for private hospitals and day procedure centres.

This Regulation is made under the *Private Hospitals and Day Procedure Centres Act 1988*, and, in particular, under sections 8 (Application for licence), 17 (Annual licence fees), 18 (Transfer of licence to another licensee) and 55 (the general regulation-making power).
