## **Explanatory note**

The object of this Regulation is to extend the exemption from provisions relating to overflows from sewerage systems contained in Regulation 10 of the *Clean Waters Regulations 1972* to sewers and sewerage systems in a number of additional locations.

This Regulation is made under the *Protection of the Environment Operations Act 1997*, including section 323 (the general regulation-making power) and clause 11 of Schedule 5 to that Act (relating to regulations made under Acts repealed by the *Protection of the Environment Operations Act 1997*).

#### 1 Name of Regulation

This Regulation is the Clean Waters Amendment Regulation 2000.

#### 2 Commencement

This Regulation commences on 7 July 2000.

Insert instead "the urban areas set out in the Schedule to this clause, but only if".
