His Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Fisheries Management Act 1994*.

Explanatory note

The objects of this Regulation are:

- (a) to repeal the provisions in the *Fisheries Management (General) Regulation 1995* that require recreational fishers to attach tags issued by the Director of NSW Fisheries to rock lobsters that are taken for recreational purposes, and
- (b) to repeal the provisions in that Regulation that require commercial fishers to attach tags to eastern rock lobsters that are taken for sale, as a consequence of the commencement of the management plan for the lobster share management fishery.

As a result of the changes, recreational fishers will not be required to tag rock lobster taken for recreational purposes.

Commercial fishers in the lobster share management fishery are still required to tag eastern rock lobsters that are taken for sale in accordance with the *Fisheries Management (Lobster Share Management Plan) Regulation 2000.*

This Regulation is made under the *Fisheries Management Act 1994*, including section 289 (the general regulation-making power).
