Explanatory note

The object of this Order is to amend the *Insurance Premiums Order 2005–2006* to provide that it is not to apply to workers compensation insurance policies that are to be or have been issued or renewed so as to take effect on or after 4 pm on 31 December 2005.

The name of that Order is, consequentially, to be changed to the *Insurance Premiums Order (July–December) 2005*.

A new Order, the *Insurance Premiums Order (January–June) 2006*, is to apply to workers compensation insurance policies that are to be or have been issued or renewed so as to take effect on or after 4 pm on 31 December 2005 and before 4 pm on 30 June 2006.

This Order is made under section 168 of the *Workers Compensation Act 1987*.

- (1) This Order applies to and in respect of policies of insurance that are to be or have been issued or renewed so as to take effect on or after 4 pm on 30 June 2005 and before 4 pm on 31 December 2005.
- (2) If, before 4 pm on 31 December 2005, an insurance premiums order has not been made in respect of policies of insurance taking effect on or after that time, this Order applies to and in respect of those policies pending the making of such an order.
