- (a) ICCR₂ in a formula in clause 1 of Schedule 5 to that Order to be the Industry Claims Cost Rate specified in Column 3 of the Table to this Notice for a class applicable to the employer concerned appearing in Column 1 of the Table opposite that rate, and
- (b) F_{117} , F_{118} and F_{119} in clause 1 (1) of Schedule 6 to that Order to be 6.66, 4.78 and 4.89 respectively.
