# Business Names Amendment (Fees) Regulation 2009

under the

Business Names Act 2002

Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Business Names Act 2002*.

## Explanatory note

The object of this Regulation is to amend the *Business Names Regulation 2004*:

- (a) to increase certain fees payable in connection with the administration of the *Business Names Act 2002*, and
- (b) to remove an outdated provision relating to a per page fee that may be waived or refunded.

The fee increases are generally in line with movements in the Consumer Price Index.

This Regulation is made under the *Business Names Act 2002*, including sections 5 and 40 (the general regulation-making power).
