Explanatory note

The object of this Regulation is to increase certain fees payable under the Registration of Interests in Goods Act 1986.

The fee increases are generally in line with movements in the Consumer Price Index. This Regulation is made under the *Registration of Interests in Goods Act 1986*, including section 21 (the general regulation-making power) and, in particular, section 21 (1) (a).
