Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Associations Incorporation Act 1984*.

Explanatory note

The object of this Regulation is to increase certain fees payable in connection with the administration of the *Associations Incorporation Act 1984*.

The fee increases are generally in line with movements in the Consumer Price Index (rounded to the nearest whole dollar).

This Regulation is made under the *Associations Incorporation Act 1984*, including sections 9(1)(g), 13(2), 14(3)(c), 20(2), 26(3), 27(1)(d) and (2), 46(3)(e), 48(3)(d), 59(3) and 73 (the general regulation-making power) and, in particular, section 73(1)(b1).
