## Explanatory note

The object of this Regulation is to increase certain fees payable in connection with the administration of the Associations Incorporation Act 1984.
The fee increases are generally in line with movements in the Consumer Price Index (rounded to the nearest whole dollar).
This Regulation is made under the Associations Incorporation Act 1984, including sections 9 (1) (g), 13 (2), 14 (3) (c), 20 (2), 26 (3), 27 (1) (d) and (2), 46 (3) (e), 48 (3) (d), 59 (3) and 73 (the general regulation-making power) and, in particular, section 73 (1) (b1).
