Explanatory note

The object of this Regulation is to increase certain fees payable in connection with the administration of the *Associations Incorporation Act 1984*.

The fee increases are generally in line with movements in the Consumer Price Index (rounded to the nearest whole dollar).

This Regulation is made under the *Associations Incorporation Act 1984*, including sections 9 (1) (g), 13 (2), 14 (3) (c), 20 (2), 26 (3), 27 (1) (d) and (2), 46 (3) (e), 48 (3) (d), 59 (3) and 73 (the general regulation-making power) and, in particular, section 73 (1) (b1).
