Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Road Transport (Vehicle Registration) Act 1997*.

Explanatory note

The object of this Regulation is to amend the *Road Transport (Vehicle Registration) Regulation 2007*:

- (a) to increase the registration fees and renewal of registration fees payable under the *Road Transport (Vehicle Registration) Act 1997* for motor vehicles and trailers, and
- (b) to increase certain fees payable for services provided by the Roads and Traffic Authority under that Act, and
- (c) to omit the fees for premium number-plates in specially styled aluminium as a consequence of the number-plates having been phased out.

The fee increases are generally in line with movements in the Consumer Price Index.

This Regulation is made under the *Road Transport (Vehicle Registration) Act 1997*, including sections 14 (the general regulation-making power) and 15 (2) (b) and (f).
