#### **Explanatory note**

The object of this Regulation is to increase certain fees payable under the *Marine Safety Act* 1998. The fee increases are generally in line with movements in the Consumer Price Index. This Regulation is made under the *Marine Safety Act 1998*, including sections 37 (2) (k) and 137 (the general regulation-making power) and, in particular, section 137 (1A).
