His Excellency the Lieutenant-Governor, with the advice of the Executive Council, has made the following Regulation under the *Home Building Act 1989*.

#### **Explanatory note**

The object of this Regulation is to amend the *Home Building Regulation 2004* to increase certain application fees payable in connection with the administration of the *Home Building Act 1989*. The fee increases are generally in line with movements in the Consumer Price Index (rounded to the nearest dollar).

This Regulation is made under the *Home Building Act 1989*, including sections 19, 24 and 30 (application to contractor licences, tradesperson and supervisor certificates and owner-builder permits of the *Licensing and Registration (Uniform Procedures) Act 2002*) and 140 (the general regulation-making power) and, in particular, section 140 (2) (j).
