- (2A) This Schedule does not apply in relation to a newly specified licence until 8 June 2010. For the purposes of this subclause, a ***newly specified licence*** is a licence that was not specified in Table 1 or Table 2 to clause 1 immediately before the substitution of those Tables by the *Liquor Amendment (Special Licence Conditions) Regulation 2010*.
