Photo Card Amendment (Fees and Penalty Notice Offences) Regulation 2010

Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Photo Card Act 2005*.

Explanatory note

The object of this Regulation is to amend the *Photo Card Regulation 2005*:

- (a) to increase the fees for the issue of a new Photo Card (from \$44 to \$45) and a replacement Photo Card (from \$21 to \$22), and
- (b) to increase the penalties for certain offences dealt with by way of a penalty notice issued under section 34 of the *Photo Card Act 2005* in relation to contraventions of certain provisions of that Act and a provision of the *Photo Card Regulation 2005*.

The fee and penalty notice offence increases are generally in line with movements in the Consumer Price Index.

This Regulation is made under the *Photo Card Act 2005*, including sections 5 (3), 34 and 36 (the general regulation-making power).
