Explanatory note

The object of this Regulation is to amend the *Road Transport (Vehicle Registration) Regulation 2007*:

- (a) to increase certain registration fees and renewal of registration fees payable under the *Road Transport (Vehicle Registration) Act 1997* for motor vehicles and trailers, and
- (b) to increase certain fees payable for services provided by the Roads and Traffic Authority.

The fee increases are generally in line with movements in the Consumer Price Index.

This Regulation is made under the *Road Transport (Vehicle Registration) Act 1997*, including sections 14 (the general regulation-making power) and 15 (2) (b) and (f).
