

# Marine Safety (General) Amendment (Fees) Regulation 2010

under the

Marine Safety Act 1998

The Administrator, with the advice of the Executive Council, has made the following Regulation under the *Marine Safety Act 1998*.

#### **Explanatory note**

The object of this Regulation is to increase certain fees payable under the *Marine Safety Act* 1998. The fees being increased relate to the following:

- (a) vessel registration (other than registration of personal watercraft and certain fishing vessels),
- (b) general and young adult personal watercraft driving licences,
- (c) general and young adult boat driving licences.

This Regulation is made under the *Marine Safety Act 1998*, including sections 37 (2) (k) and 137 (the general regulation-making power).

#### 1 Name of Regulation

This Regulation is the Marine Safety (General) Amendment (Fees) Regulation 2010.

#### 2 Commencement

This Regulation commences on 2 August 2010 and is required to be published on the NSW legislation website.
