## **Explanatory note**

The objects of this Regulation are:

- (a) to update the national schedule of demerit point offences, and
- (b) to move certain offences from the national schedule of demerit point offences, and include those offences in the schedule of additional demerit point offences, where those offences are not part of the national agreement and should not be included in the national schedule of demerit point offences.

This Regulation is made under the *Road Transport (Driver Licensing) Act 1998*, including sections 15 and 19 (the general regulation-making power).

#### 1 Name of Regulation

This Regulation is the Road Transport (Driver Licensing) Amendment (Demerit Point Offences) Regulation 2010.
