Explanatory note

The object of this Regulation is to restore increases in fees relating to the lodgement of applications to have matters dealt with in the Commercial Division of the Consumer, Trader and Tenancy Tribunal, which were inserted by the *Consumer, Trader and Tenancy Tribunal Amendment (Fees) Regulation 2010* and inadvertently omitted by the amendments made to the *Consumer, Trader and Tenancy Tribunal Regulation 2009* by the *Credit (Commonwealth Powers) Act 2010* that commenced on the same day.

This Regulation is made under the *Consumer, Trader and Tenancy Tribunal Act 2001*, including sections 40 (2) and 86 (the general regulation-making power).
