Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Associations Incorporation Act 2009*.

Explanatory note

The object of this Regulation is to increase certain fees payable in connection with the administration of the *Associations Incorporation Act 2009*.

The fee increases are generally in line with movements in the Consumer Price Index (rounded to the nearest dollar).

This Regulation is made under the *Associations Incorporation Act 2009*, including sections 6 (3) (i), 10 (3) (d), 15 (2) (c), 31 (3), 45 (2) (b), 49 (2) (b), 78 (3) (e), 98 (2) and 107 (the general regulation-making power) and, in particular, section 107 (1) (b) and (c).
