# Consumer, Trader and Tenancy Tribunal Amendment (Fees) Regulation 2011

Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Consumer, Trader and Tenancy Tribunal Act 2001*.

## Explanatory note

The object of this Regulation is to increase certain fees payable in connection with the administration of the *Consumer, Trader and Tenancy Tribunal Act 2001*:

- (a) in respect of applications to have matters dealt with by the Consumer, Trader and Tenancy Tribunal, and
- (b) for the issue of a summons, and
- (c) for a copy of all or part of a record of proceedings or other document (other than a written record or transcript of evidence or proceedings).

The fee increases are generally in line with movements in the Consumer Price Index (rounded to the nearest dollar).

The method of calculating the fee for a copy of all or part of a record of proceedings or other document has been standardised in accordance with other similar types of fees for services provided under certain other legislation administered by the Minister for Fair Trading.

This Regulation is made under the *Consumer, Trader and Tenancy Tribunal Act 2001*, including sections 40 (2) and 86 (the general regulation-making power).
