#### **Explanatory note**

The object of this Regulation is to amend the *Higher Education Regulation 2008* to increase fees payable under the *Higher Education Act 2001*. The fee increases are in line with movements in the Labour Price Index with respect to the public sector (rounded to the nearest \$10).

This Regulation is made under the *Higher Education Act 2001*, including section 25 (the general regulation-making power).
