Explanatory note

The object of this Regulation is to amend the *Tow Truck Industry Regulation 2008* to increase certain maximum fees that can be charged by the holder of a tow truck operators licence or a tow truck drivers certificate for the towing, salvage or storage of a motor vehicle that has been involved in an accident or that has been stolen, or for any service that is related to the towing, salvage or storage of such a motor vehicle.

The fee increases are generally in line with movements in the Consumer Price Index.

This Regulation is made under the *Tow Truck Industry Act 1998*, including sections 54 (Charges and fees for towing, salvage, storage and related services) and 105 (the general regulation-making power).
