Explanatory note

The objects of this Order are:

- (a) to give notice of the terms of a governing body resolution made by the Council of the Charles Sturt University under section 4 of the *Universities Governing Bodies Act 2011*, and
- (b) to set out the resultant amendments and necessary changes to the *Charles Sturt University Act 1989* and the by-laws made under it specified in section 4 (4) (b) and (c) of the *Universities Governing Bodies Act 2011*.

This Order is made under section 4 of the *Universities Governing Bodies Act 2011*.

1 Name of Order

This Order is the *Universities Governing Bodies (Charles Sturt University) Order 2012.*

2 Commencement

This Order commences on the day it is published on the NSW legislation website.

3 Notice of terms of governing body resolution and day on which it has effect

- (1) Notice is given that on 15 December 2011 the Council of the Charles Sturt University passed a governing body resolution in the following terms:
 - 1. Pursuant to section 4 (1) (a) of the *Universities Governing Bodies*Act 2011 the replaceable provisions of the Charles Sturt
 University Act 1989 are displaced and the standard governing
 body provisions (set out in Schedule 1 of the Universities
 Governing Bodies Act 2011) are adopted.
 - 2. In accordance with section 4 (1) (b) of the *Universities Governing Bodies Act 2011*, the following constitution rules are prescribed, for the purposes of the standard governing body provisions:
 - (a) the total number of members of the Council is 15, and
 - (b) the total number of members in each category is:
 - (i) 3 official members, and
 - (ii) 3 elected members (being 1 academic staff member, 1 general staff member and 1 student member), and
 - (iii) 7 Council appointed members, and
 - (iv) 2 members appointed by the Minister, and
 - (c) the minimum number of external members who must be graduates of the University is 4. They will become members by appointment by the Council.

Clause 4 Universities Governing Bodies (Charles Sturt University) Order 2012

- 3. Written advice is to be given to the Minister together with a request that the Minister make an order in accordance with section 4 of the *Universities Governing Bodies Act 2011* that will give effect to the governing body resolution.
- (2) The governing body resolution referred to in subclause (1) has effect on 1 July 2012.

4 Amendments to Charles Sturt University legislation

- (1) In accordance with section 4 (4) of the *Universities Governing Bodies Act 2011*, the amendments to the *Charles Sturt University Act 1989* and *Charles Sturt University By-law 2005* set out in Schedule 1 (other than Schedule 1 [7]) and Schedule 2, respectively, commence on 1 July 2012.
- (2) Schedule 1 [7] commences on the day this Order is published on the NSW legislation website.

8A Definitions

In this Division:

appointed member means a Council appointed member or a Ministerially appointed member.

categories of members—see section 8C (3).

constitution rules—see section 8C (4).

Council appointed member—see section 8G.

elected member—see section 8E.

external person means a person other than a member of the academic or general staff of the University or an undergraduate or graduate student of the University.

graduate member—see section 8F.

Ministerially appointed member—see section 8H.

official member—see section 8I.

8B Council

- (1) There is to be a Council of the University.
- (2) The Council is the governing authority of the University and has the functions conferred or imposed on it by or under this Act.
- (3) Schedule 1 has effect in relation to the members and procedure of the Council.

8C Size of Council

- (1) The Council is to consist of a minimum of 11, and a maximum of 22, members.
- (2) The total number of members is to be determined from time to time by a resolution passed by at least two-thirds of the members of the Council (the *total number of members*).

- (3) The Council is to include the following categories of members:
 - (a) official members,
 - (b) elected members,
 - (c) Council appointed members,
 - (d) Ministerially appointed members.
- (4) Subject to subsection (6), the number of members (other than official members) in each category is to be prescribed by rules made by the Council (in this Division called the *constitution rules*).
- (5) A rule for the purposes of subsection (4) may be made only by a resolution passed by at least two-thirds of the members of the Council.
- (6) The majority of the total number of members must be external persons.
 - **Note.** Depending on the circumstances, the Chancellor may be counted as an external person for the purposes of subsection (6).
- (7) The number of members in any one category of members must not at any time constitute a majority of the total number of members.
- (8) The Council must give the Minister written notice of the terms of any resolution passed under this section within 7 days after it is passed.

8D Qualifications and experience of members

- (1) Of the members of the Council:
 - (a) at least 2 must have financial expertise (as demonstrated by relevant qualifications and by experience in financial management at a senior level in the public or private sector), and
 - (b) at least one must have commercial expertise (as demonstrated by relevant experience at a senior level in the public or private sector).
- (2) All appointed members must have expertise and experience relevant to the functions exercisable by the Council and an appreciation of the object, values, functions and activities of the University.

8E Elected staff and student members

- (1) The constitution rules are to prescribe the number of persons to comprise the following categories of members:
 - (a) elected (academic staff) members,
 - (b) elected (general staff) members,
 - (c) elected (student) members.

Note. There may also be elected (graduate) members if the constitution rules so provide—see section 8F.

- (2) Of the members elected under this section:
 - (a) at least one must be a member of the academic staff of the University elected by members of the academic staff, and
 - (b) at least one must be a member of the general staff of the University elected by members of the general staff, and
 - (c) at least one must be a student of the University who:
 - (i) is not employed on a full-time basis (or on such other basis as the by-laws may prescribe) as a member of the academic or general staff of the University, and
 - (ii) is elected by the students of the University.
- (3) The members referred to in subsection (2) (a)–(c) are:
 - (a) to have such qualifications as may be prescribed by the by-laws, and
 - (b) to be elected in the manner prescribed by the by-laws.

8F Graduate members

- (1) At least one member of the Council, or such greater number of members as may be prescribed by the constitution rules, must be external persons who are graduates of the University.
- (2) The constitution rules may provide for the persons referred to in subsection (1) to become members of the Council in any one or more (or combination) of the following ways:
 - (a) by election as elected (graduate) members in the manner prescribed by the by-laws,
 - (b) by appointment by the Council under section 8G,
 - (c) by appointment by the Minister under section 8H.
- (3) A rule providing for the appointment of a member by the Minister under section 8H may be made only with the approval of the Minister.

(4) The members referred to in subsection (1) are to have such qualifications (if any) as may be prescribed by the by-laws.

8G Council appointed members

- (1) The Council may appoint as members of the Council such number of external persons as is prescribed by the constitution rules for the category of Council appointed members.
- (2) The by-laws are to prescribe the procedures for the nomination of persons for appointment under this section.

8H Ministerially appointed members

- (1) The Minister may appoint as members of the Council 2 external persons, or such greater number of external persons (not exceeding 6) as is prescribed by the constitution rules for the category of Ministerially appointed members.
- (2) The Minister may not appoint a member of the Parliament of New South Wales, the Parliament of the Commonwealth or another State or the Legislative Assembly of a Territory as a Ministerially appointed member.
- (3) Without limiting the discretion of the Minister under subsection (1), the Council may suggest to the Minister persons who the Council considers would be appropriate for appointment by the Minister.

8I Official members

The *official members* of the Council are the following:

- (a) the Chancellor,
- (b) the Vice-Chancellor,
- (c) the person for the time being holding the office of President of the Academic Senate (if the person is not the Vice-Chancellor) or of Deputy President of the Academic Senate (if the President is the Vice-Chancellor).

9 Term of office

- (1) Subject to this Act, a member of the Council holds office as follows:
 - (a) in the case of an official member, while the member holds the office by virtue of which he or she is a member,
 - (b) in the case of a Ministerially appointed member or Council appointed member, for such term (not exceeding 4 years)

- as may be specified in the member's instrument of appointment,
- (c) in the case of an elected member other than an elected (graduate) member, for such term (not exceeding 2 years) as may be prescribed by the by-laws,
- (d) in the case of an elected (graduate) member, for such term (not exceeding 4 years) as may be prescribed by the by-laws.
- (2) The need to maintain an appropriate balance of experienced and new members on the Council must be taken into account:
 - (a) by the Council, when making the by-laws required under this section, and
 - (b) by the Minister and the Council, when appointing members to the Council.
- (3) A person must not be appointed or elected to serve more than 12 consecutive years of office (unless the Council otherwise resolves in relation to the person).

47 Adoption of standard governing body provisions under the Universities Governing Bodies Act 2011

- (1) Terms used in this clause and also in the *Universities Governing Bodies Act 2011* have the same meanings in this clause as they have in that Act.
- (2) In this clause:

amended provision means the provisions of this Act and the by-laws amended as set out in an order made by the Minister under section 4 of the *Universities Governing Bodies Act 2011* and the constitution rules as prescribed in the resolution of the Council referred to in that order.

existing appointed member of the Council means a member of the Council as constituted immediately before the governing body resolution took effect who was appointed by the Minister or the Council.

Note. The governing body resolution took effect on 1 July 2012.

governing body resolution means the governing body resolution passed by the Council on 15 December 2011.

- (3) An existing appointed member of the Council continues in office until the expiration of the term for which the member was appointed (subject to the member's office becoming vacant earlier for a reason other than the expiration of the member's term of office).
- (4) For the purposes of subclause (3):
 - (a) an existing appointed member is taken to be a member of the corresponding category of membership set out in the amended provisions, and
 - (b) the proportion of Council and Ministerially appointed members of the Council specified under the constitution rules is, until all existing members of that category cease to hold office as referred to in subclause (3), taken to be the number of existing members in those categories at any particular time.

- (5) A person who, immediately before the governing body resolution took effect, held office as an elected member of the Council ceases to hold office on the resolution taking effect.
- (6) For the purpose only of enabling the Council to be duly constituted on or after the governing body resolution takes effect, elections for the categories of elected (academic staff) member, elected (general staff) member and elected (student) member of the Council may be conducted as if the amended provisions were in force.
- (7) Subclause (6) has effect despite any requirements of the amended provisions that elections be held at a specified time.

Note. Section 8C of the Act provides that the Council is to consist of a minimum of 11, and a maximum of 22, members, with the total number of members being determined from time to time by a resolution passed by at least two-thirds of the members of the Council. The Council resolved on 15 December 2011 that there are to be a total of 15 members. Under section 8C (3) and (4), the Council is to consist of 3 official members, 3 elected members (being one student, one member of the academic staff and one member of the general staff), 7 members appointed by the Council (4 of whom must be external persons who are graduates of the University) and 2 members appointed by the Minister. This Part provides for the election and appointment of members of the Council under sections 8E, 8G and 8H of the Act.
