Explanatory note

The object of this Regulation is to increase certain fees payable in connection with the administration of the *Associations Incorporation Act 2009*.

The fee increases are generally in line with movements in the Consumer Price Index (rounded to the nearest dollar).

This Regulation is made under the *Associations Incorporation Act 2009*, including sections 6(3)(i), 10(3)(d), 15(2)(c), 31(3), 45(2)(b), 49(2)(b), 78(3)(e), 98(2) and 107 (the general regulation-making power).
