Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Private Health Facilities Act 2007*.

Explanatory note

The object of this Regulation is to amend the *Private Health Facilities Regulation 2010* to increase the following fees in relation to a private health facility:

- (a) the application fee for a licence,
- (b) the application fee for the request for an extension of an approval in principle for a licence,
- (c) annual licence fee,
- (d) the application fee for the transfer of a licence,
- (e) the application fee for the approval to alterations or extensions to clinical areas of licensed facilities,
- (f) the application fee to amend a licence,
- (g) the application fee for a review of a decision of the Director-General of the Department of Health in relation to licensing.

The fee increases are generally in line with movements in the Consumer Price Index (adjusted to the nearest \$5).

This Regulation is made under the *Private Health Facilities Act 2007*, including sections 6(2)(f), 8(4), 14(1), 15(3)(b), 16(2)(b), 17(2)(e), 24(2)(b) and 65 (the general regulation-making power).
