1 Name of Order

Insert instead "Chief executive".

4 Construction of references to Sydney Metropolitan Development Authority

- (1) A reference in any Act, in any instrument made under an Act or in a document of any kind to the Sydney Metropolitan Development Authority is to be construed as a reference to the UrbanGrowth NSW Development Corporation.
- (2) In this clause:
