Explanatory note

The object of this Regulation is to amend the *Home Building Regulation 2004*:

- (a) to increase (from \$21 to \$22) the fee for a certificate under section 131 (Certificate evidence) of the *Home Building Act 1989* (*the Act*), and
- (b) to increase the application fees payable in connection with the administration of the $\frac{\Delta}{\Delta}$ ct

The fee increases are generally in line with movements in the Consumer Price Index (rounded to the nearest dollar).

This Regulation is made under the *Home Building Act 1989*, including sections 19, 24, 30 and 140 (the general regulation-making power).
