#### **Explanatory note**

The objects of this Regulation are:

- (a) to increase the fees payable in relation to criminal proceedings, and
- (b) to increase (from \$83 to \$85) the court costs levy so that it is in line with the filing fee for criminal matters in the Local Court.

This Regulation is made under the *Criminal Procedure Act 1986*, including sections 4 (the general regulation-making power), 4A, 114 and 211A.
