The object of this Regulation is to increase fees payable to the Registrar-General under the *Strata Schemes (Leasehold Development) Act 1986*.

The fee increases are generally in line with movements in the Consumer Price Index.

This Regulation is made under the *Strata Schemes (Leasehold Development) Act 1986*, including section 196 (the general regulation-making power).
