Explanatory note

Thiess Services Pty Limited (*Thiess*) has entered into an agreement with Sydney Water Corporation (the *Corporation*) to undertake certain services on behalf of the Corporation. A number of the Corporation's employees employed on a permanent basis are transferring to Thiess and some of those were employees for the purposes of the *State Authorities* Non-contributory Superannuation Act 1987 (*the Act*).

The object of this Order is to update the list of employers in Schedule 1 to the *State Authorities Non-contributory Superannuation Act 1987* to include Thiess. This will mean that those employees:

- (a) who, immediately before 1 July 2013, were employees for the purposes of the Act and employed on a permanent basis by the Corporation, and
- (b) who were made and accepted an offer of employment under the agreement between the Corporation and Thiess dated 25 January 2013 and known as the *Operational* (*Mechanical and Electrical*) and *Facilities Maintenance Collaborative Services Agreement*,

will continue to be covered by the State Authorities Non-contributory Superannuation Scheme.
