1 Name of Order

This Order is the *Water Sharing Plan for the NSW Murray Darling Basin Porous Rock Groundwater Sources Amendment Order 2013*.

2 Commencement

This Order commences on the day on which it is published on the NSW legislation website.

Schedule 1 Amendment of the Water Sharing Plan for the NSW Murray Darling Basin Porous Rock Groundwater Sources 2011

[1] Clause 4 Application of this Plan

Omit clause 4 (2). Insert instead:

- (2) These groundwater sources are shown on the Plan Map called the *Plan Map (WSP013_Version 2), Water Sharing Plan for the NSW Murray Darling Basin Porous Rock Groundwater Sources 2011* (hereafter ***the Plan Map***) held by the Department.

Note. The Plan Map is part of this Plan. An overview of the Plan Map is shown in Appendix 1. Copies of the Plan Map may be inspected at the offices listed in Appendix 2 and are available on the NSW Legislation website.

[2] Clauses 4, 5 and 54, Schedule 1 and Appendix 2

[7] Clause 4 (8)

Insert after clause 4 (8) (j):

- (k) the water sources as defined in the *Water Sharing Plan for the Lower Murray-Darling Unregulated and Alluvial Water Sources 2011*,
- (l) the water sources as defined in the *Water Sharing Plan for the NSW Great Artesian Basin Shallow Groundwater Sources 2011*,
- (m) the water sources as defined in the *Water Sharing Plan for the Barwon-Darling Unregulated and Alluvial Water Sources 2012*, and
- (n) the water sources as defined in the *Water Sharing Plan for the Macquarie Bogan Unregulated and Alluvial Water Sources 2012*.

[8] Clause 16 Establishment and maintenance of planned environmental water

Omit “399,786” from the note to clause 16 (2) (a) (i). Insert instead “411,280”.

[9] Clause 22 Share components of aquifer access licences

Omit “16,197” from clause 22 (a). Insert instead “16,513”.

[10] Clause 25 Volume of the long-term extraction limits

Omit “199,893” from clause 25 (2) (a). Insert instead “205,640”.

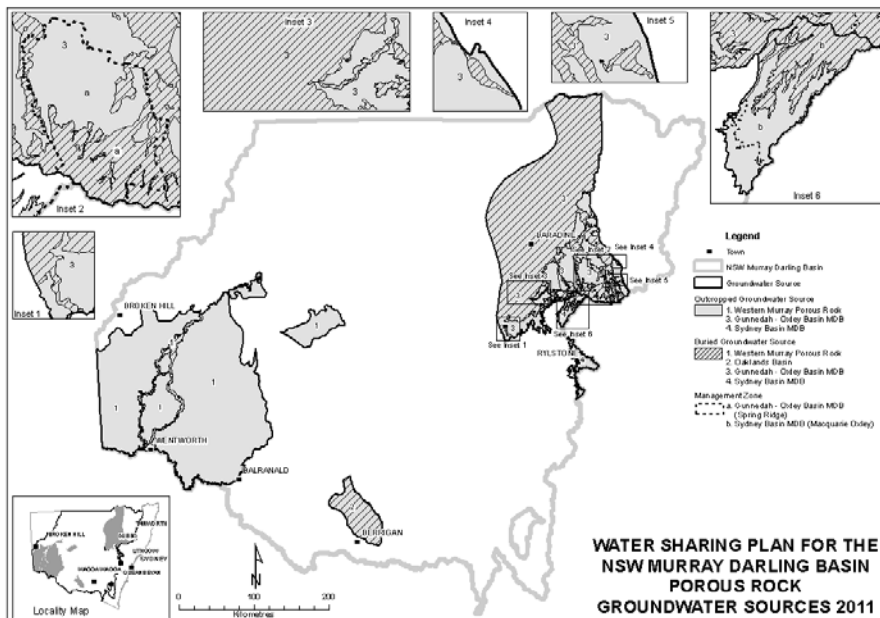
