## Explanatory note

The object of this Regulation is to prescribe the rates (per dollar of land value) at which contributions to the Mine Subsidence Compensation Fund payable by certain proprietors of colliery holdings are to be calculated for the 2013 calendar year.

This Regulation is made under the *Mine Subsidence Compensation Act 1961*, including sections 11 and 18 (the general regulation-making power).
