1 Name of Order

This Order is the Administrative Arrangements (Administration of Acts—Amendment No 1) Order 2014.

2 Commencement

This Order commences on the day on which it is published on the NSW legislation website.

3 Allocation of the administration of Acts

- (1) The administration of the Acts listed in Schedule 1 are allocated to the Ministers indicated in that Schedule.
- (2) The administration of Acts or parts of Acts that directly amend other Acts are allocated to the Ministers administering the Act amended.
- (3) The allocations made by this Order replace any previous allocations relating to the Acts concerned.

Note. See section 15 of the *Interpretation Act 1987* for the interpretation of references to "the Minister" in an Act.

4 Continuation of existing allocation of the administration of Acts

The allocation of the administration of Acts by the Governor, as in force immediately before the enactment of Part 7 of the *Constitution Act 1902* as inserted by the *Government Sector Employment Act 2013*, continues in force (subject to this Order) as an allocation under that Part.
