Explanatory note

The object of this Regulation is to amend the *Marine Safety (General) Regulation 2009* to increase certain fees payable under the *Marine Safety Act 1998* relating to State matters and National law matters. The fee increases are generally in line with movements in the Consumer Price Index.

This Regulation is made under the *Marine Safety Act 1998*, including sections 9M, 37 (2) (k) and 137 (the general regulation-making power).

1 Name of Regulation
