Explanatory note

The object of this Regulation is to increase certain fees payable to the Registrar-General under the *Real Property Act 1900*. The fee increases are generally in line with movements in the Consumer Price Index. This Regulation is made under the *Real Property Act 1900*, including sections 96B (1), 96J (a), 115 (1), 115A (1), 116, 135D (1) (c) and 144 (the general regulation-making power).
