## **Administrative Arrangements (Administration of Acts—Amendment No 2) Order 2014**

under the

Constitution Act 1902

### **1 Name of Order**

This Order is the *Administrative Arrangements (Administration of Acts—Amendment No 2) Order 2014*.

### **2 Commencement**

This Order commences on 1 July 2014 and is required to be published on the NSW legislation website.

### **3 Allocation of the administration of Acts**

- (1) The administration of the Acts listed in Schedule 1 are allocated to the Minister indicated in that Schedule.
- (2) The administration of Acts or parts of Acts that directly amend other Acts are allocated to the Ministers administering the Act amended.
- (3) The allocations made by this Order replace any previous allocations relating to the Act concerned.

**Note.** See section 15 of the *Interpretation Act 1987* for the interpretation of references to “the Minister” in an Act.
