Explanatory note

The object of this Regulation is to increase certain fees payable under the *Motor Dealers and Repairers Act 2013*. The fee increases are generally in line with movements in the Consumer Price Index. This Regulation is made under the *Motor Dealers and Repairers Act 2013*, including sections 21, 24, 34 (2), 36, 166, 177 (5) and 186 (the general regulation-making power).
