Explanatory note

The objects of this Regulation are as follows:

- (a) to prescribe fees relating to the joint registration of surveyors in both New South Wales and the Australian Capital Territory,
- (b) to increase certain fees and deposits payable under the *Surveying and Spatial Information Act 2002*.

The increases are generally in line with movements in the Consumer Price Index.

This Regulation is made under the *Surveying and Spatial Information Act 2002*, including section 36 (the general regulation-making power).
