Explanatory note

The object of this Regulation is to increase the fees payable in relation to:

- (a) the conduct of criminal proceedings, and
- (b) the provision of copies of transcripts of evidence, recorded statements and witnesses' statements, and
- (c) the functions exercised by the Sheriff in relation to criminal proceedings.

This Regulation is made under the *Criminal Procedure Act 1986*, including sections 4 (the general regulation-making power), 4A and 114.
