Road Transport (General) Amendment (Authorised Officers) Regulation 2016

under the

Road Transport Act 2013

His Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Road Transport Act 2013*.

Explanatory note

The objects of this Regulation are:

- (a) to authorise Class 2 officers (ie officers who are employed or controlled by Roads and Maritime Services) to issue penalty notices for certain traffic offences under the *Road Rules 2014*, and
- (b) to enable those officers to issue penalty notices for breaches of Rule 187 (1) of the *Road Rules 2014*, which prohibits unauthorised stopping in a bus, transit or truck lane.

This Regulation is made under the *Road Transport Act 2013*, including sections 23 and 24 (the general regulation and rule-making power) and 195 (Penalty notices for certain offences) and Schedule 1.

1 Name of Regulation

This Regulation is the *Road Transport (General) Amendment (Authorised Officers) Regulation 2016*.
