# Crown Lands (General Reserves) Amendment By-law 2016

## Explanatory note

The objects of this By-law are as follows:

- (a) to extend the application of the *Crown Lands (General Reserves) By-law 2006* (the ***principal By-law***) to a further 38 reserves,
- (b) to update references to the locations, names and descriptions of certain reserves, and to the corporate names of trustees for certain reserves, to which the principal By-law applies,
- (c) to omit reference to Broken Head Reserve as a reserve to which the principal By-law applies (its reserve status having been revoked).

This By-law is made under section 128 of the *Crown Lands Act 1989*.
