## **Explanatory note**

The object of this Regulation is to increase the penalties for offences under the *Roads Regulation 2008* dealt with by way of a penalty notice issued under the *Roads Act 1993*. The increases are generally in line with movements in the Consumer Price Index.

This Regulation is made under the *Roads Act 1993*, including sections 243 and 264 (the general regulation-making power).
