Explanatory note

The object of this Regulation is to amend the *Public Authorities (Financial Arrangements) Regulation 2013* to confer investment powers on the Treasurer so that the Treasurer can make, in respect of funds for which an approved funds manager is engaged, investments of any kind.

This Regulation is made under the *Public Authorities (Financial Arrangements) Act 1987*, including sections 24 and 43 (the general regulation-making power).
